The call for proposals for the 33<sup>rd</sup> Annual Teaching Public Administration Conference is now open. The conference will be held Thursday, May 13 through Saturday, May 15, 2010 in partnership with Grand Valley State University in Grand Rapids, Michigan. This conference welcomes ideas and proposals from all disciplines and individuals passionate about the meaning of SERVICE and COMMUNITY. Presenters are invited to share their ideas, knowledge, and experiences through lecture, discussion, role play, game, audio, video, or any other pedagogy. Authors can submit their papers for possible symposium inclusion in the *International Journal of Organization Theory and Behavior* (IJOTB), and articles that address teaching in and administration of public affairs/administration and nonprofit programs can be submitted for a symposium in the *Journal of Public Affairs Education* (JPAAE).

- a) A separate title page that includes the paper’s title, name of author(s), and contact information NOTE: Audio-visual requests should be listed on the detachable title page.
- b) A summary of the proposal which includes: Presentation Title, Presentation Objectives, Presentation Activities, Session Format (see below), Relevant Bibliographic Citations on Topics, Presentation Description (75 words maximum).

#### Session Formats

- Panel discussion, demonstration Project, or Debate: 90 minute presentation by a panel of 3-5 colleagues on a topic of general interest.
- Workshop: 90 minute interactive presentation.
- Individual paper: 20-30 minute presentations that will be grouped with other presenters for discussion.
- Round Table: 45 minute, informal, small group discussions. Ideal forum for presenting works in progress.
- Poster Session
- Other: Please delineate time and configuration.

#### Timeline:

1. Deadline for submission of abstracts and other proposals: First call – December 18, 2009. Second call – March 5, 2010.
2. Notification or acceptance of proposals: First acceptance – January 15, 2010. Second acceptance – March 26, 2010
3. Abstracts and papers due: April 23, 2010.
4. Papers due for symposium consideration to the *Journal of Public Affairs Education* and *International Journal of Organization Theory and Behavior*: July, 2010.
