- Details of the publishing platform, technology, and user features.
- A proposed plan for maintaining and improving access for NASPAA members.
- A description of peer-review and editorial support services.
- Marketing and distribution strategies for both electronic and print formats.
- A financial proposal, including cost structures for electronic and print publication.
- Proposed terms of the partnership, including contract length and key deliverables.

### SUBMISSION PROCESS

Proposals must be submitted by **March 5, 2025** to **jpae@naspaa.org**.
